I. ANSWERS TO PRE-BID INQUIRES

1. Q: Is the Contractor to perform all electrical and fire alarm work?

A: Yes, the Contractor, as part of this scope of work, is responsible for <u>all</u> electrical, telecom and fire alarm shown on the bid documents, unless noted otherwise to be provided by the Portable Building Manufacturer. For example see notes 9 and 10 on sheet E202.

2. Q: Who provides the handrail extensions per detail 17/AS102?

A: The Contractor shall provide all required extensions. The portable building manufacturer provides a pre-fab metal ramp and handrail. The Contractor is responsible to provide asphalt paving to provide a flush transition to the metal ramp along with the required handrail extension. The handrail extension shall be welded, grind/sand smooth, and painted in order to provide a smooth and seamless transition that matches the handrails provided by the portable building manufacturer. Handrail and ramp extensions shall be ADA compliant. Refer to ramp details on sheet S5R of the AMS drawings for more information.

3. Q: Is there a top of wall detail for the new wall to be provided in the Faculty Office portable building?

A: See detail 5 on AMS drawing sheet S2A.

Q: Within the General Conditions of the Contract, Attachment D, Schedule of Milestones, it states to prep the site for the portable building manufacturer to deliver and place the portable building on Saturday, August 31, 2019. This date coincides with Labor Day weekend, can this date be moved?

A: Yes, the portable building manufacturer will move this delivery and placement date to Saturday, September 7, 2019.

5. Q: Per General Conditions article 17.53 Electrical Equipment, it requests the Contractor to expedite the procurement and delivery of the electrical equipment. To expedite, can we provide a dry type transformer that will provide the equivalent power and output as noted on sheet E003?

A: Yes, dry type transformer is acceptable.
