**Mandatory Pre-Bid Conference:** A mandatory Pre-Bid Conference will be conducted on, **May 1, 2019**, beginning promptly at **3:00 p.m.** Participants shall meet at Long Beach Community College, Liberal Arts Campus, 4901 E. Carson Street, Building B, Room 203, Long Beach CA 90808. Only bidders who participate in the Conference in its entirety will be allowed to bid on the project as prime contractors. Participants must arrive at or before **3:00 p.m.** Parking is available in unmarked stalls in either the parking structure off Clark Ave., or at Veteran's Stadium near the corner of Lew Davis Drive and Faculty Avenue. Parking passes are available for purchase at the kiosks. Any persons arriving later than said time will not be allowed entrance into the conference or be allowed to bid on the project as prime contractors. **License Requirements:** The successful Bidders and subcontractors will be required to have current and active California Contractor's Licenses at the time of submission of the Bid. **Licenses required: B.**

**Bid Security Required:** 10% of the maximum amount of the Bid Proposal in the form of Bid Bond, Cash, or Certified or Cashier's Check.

**Bonds Required:** Performance and Labor & Materials 100%.
